

RESOLUTION 2014-45

A RESOLUTION TO DESIGNATIONS OF THROUGH HIGHWAYS, CONTROLLED INTERSECTIONS, AND LOCATION OF STOP SIGNS FOR THE VILLAGE OF MUKWONAGO

WHEREAS, the Village Board, based on recommendations by Village staff, has determined that it is more cost effective to amend and more administratively effective to maintain the designations of through highways, controlled intersections, and location of stop signs in a resolution rather than an ordinance; and

WHEREAS, some changes have been made during the transfer of the information from Sections 82-96 through 82-98 of the Municipal Code to this resolution; and

WHEREAS, the Village Judicial Committee has reviewed said designations of through highways, controlled intersections, and location of stop signs;

NOW THEREFORE, the Village Board of the Village of Mukwonago hereby modifies such designations of through highways, controlled intersections, and location of stop signs as defined in the attached schedule and be effective on December 16, 2014 and remain in effect until changed by resolution of the Village Board.

DESIGNATIONS OF THROUGH HIGHWAYS, CONTROLLED INTERSECTIONS, AND LOCATION OF STOP SIGNS

In reference to Section 82-96 through 82-98 of the Municipal Code

Designation of through highways. In the interest of public safety and pursuant to authority granted by state law, the following highways or portions thereof are declared to be through highways:

1. Fox Street from the east village limits to the intersection with STH 83 (South Rochester Street).
2. Main Street from the intersection of South Rochester Street southerly to the south village limits.
3. STH 83 from the north village limits to the intersection with CTH ES (Fox Street).
4. STH 83 from the intersection with Fox Street southerly to the south village limits.
5. CTH LO from the intersection with STH 83 (North Rochester Street) westerly to the west village limits.
6. CTH NN from the intersection with CTH ES (Fox Street) westerly to the west village limits.

Designation of controlled intersections. In the interest of public safety, the following intersections are declared controlled intersections, and traffic control signals shall be installed thereon in conformity with the Wisconsin Official Control Device Manual and the provisions of this chapter:

1. The intersection of STH 83 (North Rochester Street) with CTH NN.
2. The intersection of STH 83 with CTH ES.
3. The intersection of STH 83 with Bay View Road.
4. The intersections of STH 83 with both Interstate Highway 43 ramp terminals.
5. The intersection of STH 83 with Wolf Run and East Wolf Run.
6. The intersection of CTH ES with Bay View Road.
7. The intersection of CTH NN with CTH EE.
8. The intersection of CTH NN with the entrance to the Mukwonago High School.
9. The intersection of CTH ES with CTH NN and Holz Parkway.

Designation of location of stop signs. In the interest of public safety, stop signs shall be installed at the following locations to control traffic on the highways over which the village has jurisdiction
