## Notice of Rate Increase

### Water Customers of the Mukwonago Municipal Water Utility

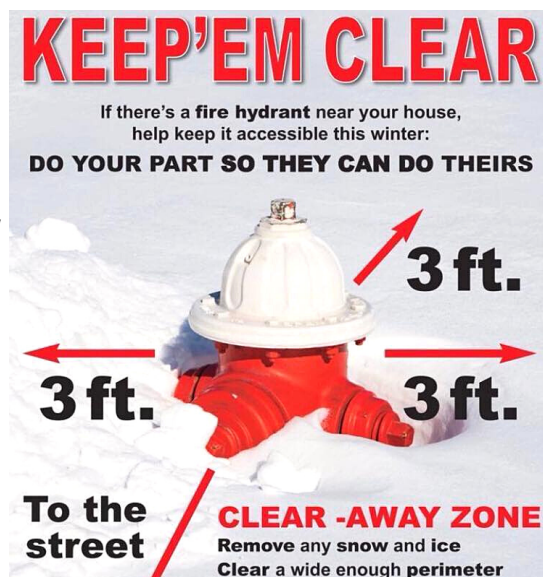
This is to give you notice that the Mukwonago Municipal Water Utility will file an application on November 22, 2021, with the Public Service Commission of Wisconsin (PSC), for authority to increase water rates. Rates for general service will increase 3.0 percent. The increase is necessary to reduce the existing deficiency in present rates. The request is being made under Wis. Stat. 196.193. Rate increases granted under this statute do not require a public hearing. The effect of the increase for some selected customers is shown below. Public Fire Protection and Wholesale rates (if applicable) will also increase 3.0 percent.

## Snow Removal Reminder

Remember to keep the sidewalks, handicapped access ramps and fire hydrants adjacent to your property clear of snow and ice. Sidewalks and ramps must be cleared the full width (not just a path). Fire hydrants must be cleared of snow and ice in the area 3' from the hydrant and a 3' wide path from the hydrant to the street. Code 74-8 that was amended in April 2021



## DOG LICENSING

Under Chapter 14 of the Village Municipal Code, the owner of any Dog must obtain a license. Dog license applications are available at Village Hall, or online at [www.villageofmukwonago.com](http://www.villageofmukwonago.com) under Forms and Applications.

A current rabies certificate from your veterinarian IS REQUIRED when applying for the license.

License fees vary depending on the County you reside in.

Please log online and review our application. If you wish to have a license mailed to you, please include a self-addressed stamped envelope.

A late fee of \$5.00 will be charged after March 31st

## NEW RECYCLING FEE

Recycling Fee Increase Goes into Effect the First Quarter of 2022

As of January 1, 2022, new recycling fees will go into effect for the first quarter of 2022. The fee will increase 3.5% from \$21.42 to \$22.17 per quarter compared to no increase in 2021.

## 2021 Important Resident Tax Collection Information

### INSTALLMENT DATES

First installment is due January 31st

Second installment is due July 31st

If any installment is not paid by the due date, the entire balance of the tax bill will become delinquent with interest retroactive to February 1st. If you wish to request a copy of your receipt you must include a self-addressed stamped envelope
